



**Event Indemnity Form**

To: Hampton Downs MotorSport Park Limited ("HDMP")

and to: All Employees of Hampton Downs Motorsport Park Limited ("HDMPE")

I, the undersigned, hereby confirm and warrant and agree to be bound by the following terms and conditions in favour, and for the benefit of, **HDMP** and **HDMPE**:

1. **I warrant that:**
  - (a) **I am over eighteen years of age;**
  - (b) **I hold a current full driver's licence and not a probationary licence; and**
  - (c) **I have not consumed any alcohol or other drugs or substances which may affect my ability to drive, for the period of twelve (12) hours before signing this indemnity form.**
2. I will comply with the Occupational Safety and Health Regulations provided to me by **HDMP** or **HDMPE** at all times, including the wearing of full safety clothing and gear at all times whilst required.
3. I will at all times comply with the instructions of the **HDMP** and **HDMPE** employees and agents.
4. I will not allow any person other than the person named on this form to drive the entered vehicles.
5. I will not enter the Hampton Downs Circuit without first obtaining the Hampton Downs Circuit Manager's permission.
6. I will exercise all due care, will not drive negligently or recklessly and will at all times comply with the Safety Regulations of the Hampton Downs MotorSport Park.
7. I understand that the Hampton Downs Circuit Manager or any of their employees or agents may terminate and prohibit my access to the facility if I drive recklessly, dangerously, or breach any of the terms in this indemnity form.
8. I will be responsible for and will pay to make good any damage I may cause, whether deliberately or otherwise, to any property of Hampton Downs Motorsport Park.
9. I will not hold **HDMP** or **HDMPE** responsible for any damage, injury or death caused by mechanical failure or otherwise of any vehicle supplied by those parties, whether directly or through a sub-contractor, or due to the state of the Hampton Downs Circuit.
10. I understand that in consideration of **HDMP** granting me permission to use the Hampton Downs Circuit I warrant all of the above and will indemnify **HDMP** and together with their employees, directors, officials, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss or damage to person or property however caused, arising out of or in connection with my use of a vehicle and the Hampton Downs Circuit, including claims by third parties, notwithstanding that such claims may have been contributed to by the fault or negligence of **HDMP** or **HDMPE**.
